The **Economic Development Alliance of Lincoln County** (EDALC) is an independent Oregon 501(c)(6) nonprofit economic development organization (EDO). EDALC staff members work every day to attract, support and grow businesses in Lincoln County to ensure community-wide economic well-being and an improved quality of life. EDALC has served Lincoln County for over 30 years as its only EDO and is governed by a local board of directors. We receive our funding from local governmental units, our local business community and grant dollars.

OUR MISSION – To deliver economic development services to facilitate creation, growth and retention of Lincoln County businesses.

OUR VISION – The Economic Development Alliance of Lincoln County leverages information and relationships to enhance an environment for investment in Lincoln County.

Keeping Lincoln County Active in our Regional Economic Ecosystem

While **EDALC** primarily serves Lincoln County, we understand that we are part of several overlapping economic ecosystems, which, in turn, are all part of the economic fabric of the State of Oregon. Lincoln County is one of the four counties (the others being Benton, Lane and Linn counties) within the federally-designated **Cascades West Economic Development District**. Lincoln County is also a coastal county, sharing a rural coastal economy along Oregon's entire 362 mile long coastline.

Supporting Lincoln County's Entrepreneurial Ecosystem

Small businesses are the backbone of Lincoln County's economy. As well as our numerous startups and the local innovators who are planning their next business venture, most of our local business owners are true entrepreneurs. Through our work as a member of **Business Oregon's Rural Opportunity Initiative** program, **EDALC** works to help create and support the scaffolding that supports our entrepreneurs - our **Entrepreneurial Ecosystem**.

- **Youth Entrepreneurship Program** - Pitch Event, May 2024 in Newport and May 2025 in Lincoln City (in partnership with the Oregon Coast SBDC)
- Business **PitchFest** - creating a new event in 2025 to celebrate innovative startup ideas
- **FailFest** - entrepreneurs sharing their stories of business failure (as fertilizer for future success) in a supportive event - 2023, 2024 and coming in 2025
- **Cascades West Innovation Hub** - designing the operating framework for a regional innovation hub
- Developing a **Creative Economy Playbook** for Rural Communities and Solopreneurs
- **ART Toledo** - support grassroots efforts to revitalize downtown Toledo via the Creative Economy
- **Video Grant Recipient** - Funded by the Rural Opportunity Initiative, crafted by TZOM Films






Supporting Increased Broadband Deployment and Access in Lincoln County

The **American Rescue Plan Act (ARPA)**, signed into law in March 2021, includes over \$18 billion in funding for broadband and fiber projects, administered through the **National Telecommunications and Information Administration (NTIA)**. Oregon's share is \$688 million, which will be distributed by the **Oregon Broadband Office (OBO)** through multiple broadband infrastructure and digital equity programs. So far, over \$10 million dollars has been awarded for infrastructure work directly in Lincoln County through USDA's **reConnect** program as well as the OBO's **Broadband Deployment Program (BDP)**.

- Regional **Broadband Action Team (BAT)** - EDALC represents Lincoln County at the four-county BAT table for the last three years and counting. Our local BAT includes OBO representation, key broadband leaders, governmental entities and Internet Service Providers (ISPs).
- EDALC provided Lincoln County leadership and direction during the development of an EDA-funded three county **Broadband Strategic Planning** grant.
- EDALC has supported all key infrastructure grant applications to NTIA, BDP, BTAP and USDA reConnect - with awardees including the **Confederated Tribes of Siletz Indians (CTSI)** and **Pioneer Telephone Cooperative**.





Helping the Oregon Coast Grow its Blue Economy Sector

Powered by a \$1 million, three-year **Congressionally Directed Spending Grant**, EDALC has been leaning into **Oregon's Blue Economy**. Recognizing a need (during EDALC's pandemic work) to coordinate and collaborate along our rural coast, we are working to "asset quilt" our innovative ocean-dependent businesses to create new opportunities to grow this emerging sector statewide.

- **Expanding Markets Study: Blue Economy** - served on the coordinating team of this Business Oregon funded study
- Supporting five coastal blue incubators - granting out **over \$400K** to date
- North coast data modeling - working with the Columbia Pacific EDD to create a model for coast-wide **Blue Economy data analysis**
- Supporting green methanol research to help **decarbonize maritime/fishing emissions** - submitted for a phase-one Department of Energy STTR grant
- Funding two OCCC Developing a Curriculum (DACUM) processes: **Aquaculture Technician** and **Maritime Technician**
- Developing F/V business plan with financials to help in **decision making**






Providing Meaningful Data and Information to Lincoln County Decision Makers

Lincoln County Major Employers Report, 2024






Managing Impactful Local Economic Development Tools


EDALC provides and supports impactful economic development tools. Our organization manages the **Lincoln County Enterprise Zone**, providing tax relief for business investments that lead directly to job creation. **Oregon Prospector** works with local realtors to expand the coverage of available local commercial real estate. EDALC has managed Lincoln County's **Community and Economic Development Grant Program** for over a dozen years.

- **Lincoln County Enterprise Zone** - over \$5M in private investment over past five years, leading to the creation of 25 new FTE jobs
- **Oregon Prospector** - over 80 current active listings - third highest listing count in the State of Oregon
- **Community and Economic Development Grant Program** - \$130,000 granted out each year over the past five years for innovative economic development projects

Fostering Connections and Collaboration on the Oregon Coast

The **Community Connector** (CC) role, though relatively new to EDALC, is rooted in over seven years of built relationships and understanding of Lincoln County and the Pacific Northwest Coast's strengths, challenges and systems. Moving away from the "way things have always been done," the CC utilizes the **Rural Community Building Approach** to work alongside collaborators to support system-improving solutions that range from aligning existing efforts to catalyzing dynamic, community-centric shifts. Successful outcomes look like mutually beneficial recommendations that become self-sustaining and spread organically while also inspiring participation from those previously uninvolved.

Innovating in Economic Development's Adjacent Possible Space

EDALC pursues time-tested economic development strategies, while at the same time striving to develop **new and innovative approaches to rural economic development**. Our Deck of Lenses tool allows our communities to ask vital questions from new and unexpected vantage points. Our strategic planning “gamification” helps communities understand multiple forms of community capital and work to make decisions with limited resources in an engaging way. Our research has underscored the need for an innovative, flexible and sustainable business incubator for Lincoln County.









Seeking Equitable, Diverse Funding for Financial Sustainability

In 2020, **EDALC's Board of Directors** moved to diversify organizational funding, with an eye towards sustaining impactful and innovative economic development work for years to come. EDALC's first task was to develop a solid value proposition and a clear strategic focus. Armed with **proven results** and a set of strategic priorities, EDALC's staff worked to craft a funding model unique to Lincoln County (since traditional EDO funding by traded sector companies isn't a viable option here) and spread out between public sector funding, private sector funding and grant funding.

- Pre-2019, EDALC was funded by a single source, with only occasional grant funds
- Since 2020, EDALC's funding has diversified, and its budget has grown three-fold, to approximately \$360,000 annually
- EDALC has grown from 1.5 FTE to **four full-time, professional staff members**, each with years of experience and complementary areas of expertise
