The Chamber is seeking funding to replace the existing monument sign at the Chamber office with a modern energy-efficient digital sign. The new sign will have dynamic messaging capabilities which will allow for real-time updates including emergencies and critical safety information. It will also give local business owners a very visible avenue to market their promotions & events which will support economic growth and foster collaboration within the business community. The current sign is not lit at night, which is essential during the dark winter months, as it ensures that critical messages and community updates remain visible and accessible, even in the early evening or overcast conditions. The new digital sign will serve as a beacon of light, guiding people toward opportunities and fostering a thriving community year-round.
