Project Description*

The Lincoln County Master Gardener™ Association (LCMGA) will be conducting an inaugural offering of an educational conference titled: Spring into Sustainable Gardening. It is our intention to hold this conference annually and this grant will help us realize this organizational goal. We are seeking funding to partially support this event. The focus of the conference will be to educate Lincoln County residents about sustainable gardening practices that they can implement in their personal gardens and landscapes. The format of the conference will include lectures and poster presentations where participants will have the opportunity to interact with local Master Gardeners™ who will utilize the latest research to quide discussions. Topics include turf replacement, gardening with native plants, integrated pest management, gardening for pollinators, sustainable landscape design, soil management, and rainwater catchment. Our target audience will be the residents of Lincoln County, and grant funds will be used to offset registration fees. There will be no charge to participants. The conference will be held at a mid-county site, the Samaritan Center for Health Education in Newport, which accommodates approximately 130 participants. Master Gardeners are uniquely qualified to offer education on sustainable gardening practices to residents of Lincoln County. Members of our nonprofit organization have had a long and successful history of supporting our residents with reliable science-based gardening education. Most recently, this Fall, we offered a series of courses in collaboration with the Oregon Coast Community College on a variety of gardening topics. As the name implies, the focus of this conference will be on sustainable gardening, which will impact our communities in numerous ways. By definition, sustainable gardens thrive with minimal input of labor, water, fertilizer and pesticides. This approach to landscape and gardening minimizes environmental impact, preserves natural resources and promotes biodiversity. Local gardeners will be empowered to improve the environment for people, plants, and wildlife right where they live, here in Lincoln County. Gardeners focusing on sustainable vegetable gardening can have additional positive impacts by improving the quality of their soil and produce and reducing food insecurity. Home gardeners who use sustainable practices can also play a role in a solution to climate change. Lastly, gardening in general can be a boon to physical, psychological and social health. To promote sustainable practices, we will have two lectures, provided by experts. We intend to engage Oregon State University staff and faculty to serve as experts. The remaining time will be spent in a poster presentation format with personal interaction between participants and local Master Gardeners. It is our expectation that through this relational format, we will have a positive impact on our participants and our community. Further opportunities for observation of these gardening techniques can be found in the LCMGA Demonstration Gardens at Oregon Coast Community College campuses in Lincoln City, Newport and Waldport, In addition to demonstrating garden practices at these sites, LCMGA offers gardening programs for youth and the general public which have an impact on much of Lincoln County. We will continue to provide an ongoing resource to help interested community members in implementing sustainable gardening techniques through our Plant Clinic, where Master Gardeners answer questions submitted by the public with research-based responses. The materials developed for the conference will be re-used for future Education and Outreach by the Lincoln County Master Gardeners Association.

Funding*

The LCMGA will be contributing up to \$500 to pay for event speakers. Speakers have been engaged but, to date, not confirmed. The LCMGA will also be contributing 60+ volunteer hours the day of the event. Volunteer hours are not monetized in the budget. The LCMGA is asking for grant funding for direct program cost. We will not be charging attendees.

Attendance and Survey responses will indicate the success of the project. The project will not need ongoing funding. It is the intent of the LCMGA to conduct a Spring conference every year, this being the inaugural event. Funding this event will provide a strong foundation for future event success.
