#### **Project Description\***

Three years ago, Oregon Coast Council for the Arts (OCCA), in collaboration with the Newport Chamber of Commerce's Leadership Lincoln program, created a free community festival called "Bloom Newport." This springtime community celebration centers around art, food, conservation, and music and creates a unique platform for educational opportunities. The values of "Bloom Newport" are rooted in accessibility. community empowerment and shared responsibility. We are proud to host an ever-expanding roster of vendors which represents a cross-section of our innovative and creative community. Their participation and our promotion help them to thrive by increasing their visibility and profits. Last year's festival had 57 vendors and over 800 attendees. The vendors covered a breadth of businesses and services spanning small businesses, local breweries, restaurants, health and human services, environmental education, artists and makers, and uniquely, a surf swap that provided equipment and educational opportunities for our bustling surfing community. This year, we hope to be able to expand the footprint and scale of this popular community gathering. We plan to expand along NW Cliff street - creating a promenade for more businesses and artists to participate and to allow for more guests to stroll and enjoy this festive event! The Bloom Newport Festival not only provides benefits for our local vendors and community members, but also bolsters our tourism economy as it attracts visiting vendors and festival goers to our area who support our hospitality and restaurant industry. We know from the 2022 Arts & Economic prosperity study, that the average spending for event attendees in Lincoln County specifically is \$50.47 per person, per event. That's an average across both visitor spending (\$115 per person, per event) and local spending (\$19 per person, per event). That is spending above and beyond tickets or admissions. If we use last year's attendance figures, that means roughly \$40,000+ is generated by this event for local business; an outstanding ROI for a \$7,000 investment by EDALC! When we gather and celebrate with community, local businesses absolutely benefit! Another important benefit of "Bloom Newport" is to our local artists and makers of which there are many in Lincoln County. Particularly since the pandemic, artists have struggled to find opportunities that pay them equitably. Funding for Bloom Newport provides an opportunity for creatives to showcase their craft, network for future business, and sell their creations and services.

#### Funding\*

For this year's "Bloom" community event, there are three primary funding sources: OCCA budget, a small amount of vendor/booth fees, and grant funding. OCCA budget funding is currently in place for this event. The grant funding we are seeking from EDALC will allow this event to grow in its impact and scale this year. We have not applied to any other funding sources at this time.

#### **Collaboration\***

The idea of "Bloom Newport" was born of collaboration and remains so to this day. Initially this was a class project out of Leadership Lincoln, lead by colleagues from OCCA, OCCC, Rogue, Wolftree and Lincoln County Human Services. Now, three years later, the collaboration continues to grow with many of the founding members still involved in its development and success. Each year, the next Leadership Lincoln class is invited to select this event as part of their community projects. That allows new community leaders (and businesses) to get involved and bring their ideas and enthusiasm into this truly collaborative community project. Returning this year on the core planning team, working with Leadership Lincoln participants, are staff from OCCA, OCCC and Rogue.

#### Viability\*

The Bloom festival grows every year, and one of our main indicators of a successful festival is a count of attendance. We plan on hosting over 1,000 attendees this year. We are currently working with the city of Newport to expand Bloom's footprint in order to include the esplanade connecting Newport's performing arts center to the visual arts center. This new footprint will provide space for at least 10 more vendors, and provides visibility for the visual arts center who hosts art classes, workshops, and educational opportunities for the central Oregon coast. Part of Bloom's success in 2025 can be gauged by successfully implementing this expansion. Pending grant funding this year, we anticipate building a NEW, dedicated "Bloom Newport" website fully developed before the 2025 festival on which we will ask vendors and attendees for feedback. Our new website will also be a landing page for improved volunteer organization, marketing and promotion, and for communicating with our vendors and artists. Finally, after each Bloom Newport, our steering committee considers the entire event, exploring what worked well and what needs improvement. Feedback is solicited directly from local businesses and participants to look for ways we can improve and grow the event. This project will continue to have budget allocation from OCCA to allow it to continue on a smaller scale in the future. Outside, contributed grant funding will allow us to grow and build this event in exciting ways and for greater economic impact.
